

ETERNAL® odstraňovač plísní

Special agent for liquidation of fungi, mold and algae on walls

Features:

ETERNAL odstraňovač plísní is special agent eliminating fungi, mold, and algae on walls. **ETERNAL odstraňovač plísní** has a wide spectrum of usage including molds, fungi, bacteria, algae, mosses and lichens. Interval of 1 hour is needed for fungicide effect, 3 days are needed in case of algae elimination.

Type of product 2; 10

Form of product: water dispersion, spray

Usage:

ETERNAL odstraňovač plísní is suitable for elimination of biotic contamination of walls, roofing and other surfaces.

Consumption:

0,10–0,2 kg/m²

Packaging:

0,5 kg plastic bottle with sprayer, 5 kg plastic containers

Storage:

In original unopened containers from 5 °C to 25 °C on a place with no food, drink and feed presence. It must not freeze, be stored in high temperatures and direct sunlight.

Surface preparation:

Before applying **ETERNAL odstraňovač plísní** it is necessary to clean the surface mechanically (by high-pressure washing), get rid of all deposits of unwanted pollution and let dry.

Application:

ETERNAL odstraňovač plísní is applied by brush or roller (for local application it is possible to use spray) on a dry contaminated surface, which was cleaned before of all unwanted pollution. Contaminated surface needs to be covered by the product evenly and properly, so that the active substrate penetrates the surface as deep as possible and eliminates the spawn of fungi and mold. Surfaces with high absorption need extra care. It is recommended to apply mold, fungi and algae-resistant coating on the treated surface after drying as soon as possible. For example, special silicone facade coating **SANATHERM B silikon PREVENISIL**, **ETERNAL IN steril** or **ETERNAL IN silver** in the interior, to prevent new contamination.

Waste disposal:

Described on safety data sheet of the product.

Safety and hygiene at work:

According to the law, **ETERNAL odstraňovač plísni** is classified as dangerous. Contains an octhiline (ISO) (0,5 g/1 kg) and dodecyldimethylamoniumchloride (20 g/1 kg). Causes serious eye irritation. Causes skin irritation. It contains octhiline (ISO) [ES: 247-761-7]. May cause an allergic reaction. Keep out of reach of children. Wear protective gloves/protective clothing/eye protection/face protection. IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and possible. Continue rinsing. IF ON SKIN: Wash with plenty of soap and water. If eye irritation persists: Get medical advice/attention. If skin irritation occurs: Get medical advice/attention. See special instructions on safety data sheet. **Use biocides safely. Always read the label and product information before use.** Re-usage of packaging is not allowed.

First aid:

Wash skin with soap and water. If swallowed, rinse mouth with tepid water and drink about 0,5 liters of tepid water with 10 crushed charcoal tablets. Seek medical help. Do not induce vomiting. If inhaled, move to fresh air, in case the symptoms persist, seek medical help. Other details are on the Safety data sheet of the product. **ETERNAL odstraňovač plísni** is non-flammable liquid in terms of ČSN EN 65 0201.
